In accordance with a mutual desire for cooperation and collaboration aimed at improving, strengthening and promoting the relations between the above two schools of our respective institutions, the **Department of Interior Architecture** at EMU represented by **Asst.Prof.Dr. Ozlem Olgac Turker, Chairperson** and the **Department of Koninklijke Academie voor Schone Kunsten** represented by **Wim De Temmerman, Dean**, have agreed upon the general terms of the present agreement.

## Article I

Both departments hereby express their intention to promote cooperation between academic members, students and research groups.

## Article II

Within the framework of the fields of common interest, both departments will abide by the following general principles of consideration:

1. deriving mutual benefit from the contribution of each department's knowledge and experience to the solution of problems of mutual interest;
2. promoting and encouraging the training and development of academic staff;
3. exchanging invitations to scholars and students in order to participate in academic activities such as exhibitions, lectures, conferences, symposia, workshops, and exchanges of experience;
4. facilitating exchange of experiences and opinions, to mutual benefit.
5. promoting and encouraging the activities of staff and students in fields of common interest;
6. exchanging artistic and educational data, where possible, to be used for education and training purposes.
7. promoting and encouraging the exchange of academic staff and students.

## Article III

The precise nature and specific details of collaboration between the two departments, including topics of common activities and formalities concerning visits, exchanges, and other forms of cooperation, will be defined by mutual agreement in "Working Documents" to be prepared by the authorized official representatives of the two departments who wish to collaborate under the framework of this agreement.

## Article IV


The "Working Documents" referred to in Article III shall be adjusted from time to time as deemed necessary, in accordance with new developments and requirements on the part of one or both departments. These adjustments should have the prior written approval of both departments who are signatories to this agreement.

## Article V

This agreement is written and signed in English in two copies. The present agreement will come into force as soon as it has been signed by the authorized representatives of the two departments and will remain in force for a five year period from the date of execution and may be renewed for an additional five years upon mutual consent. The agreement may be terminated by the authorized official representative of either department by written notice. Such notice must be given at least three months before it becomes effective. Such termination shall not affect the completion of any activity underway at the time or the rights of individuals exchanged under this agreement, prior to the notice of termination.
