In order to interrogate vernacular architecture, fractal geometry is one of the most advanced methodologies in this study. Vernacular architecture is an organic architecture, which is formed in response to environmental, cultural, economic factors. There are plenty of variations in topography; climate and geographical issues among the mountainous areas in Iran. Therefore, there are many useful thought, which can be learnt from the existing vernacular architecture. This study is going to investigate fractal pattern of housing in Masouleh village, Iran. By referring to the fractal dimension calculated with box counting method, different type of information will be collected and this attempt will help decision makers, planners, architects and designers, especially in new housing developments.

characteristics in spite to the rapid changes that have occurred socially, economically and demographically ever since. Another determinative thought in selecting the settlements was to distinguish between the geographical and topographical regions of these settlements. The settlement being on the high lands would differentiates in its architectural expression since the economical essences, and the other means of building culture would be different then of the one existing on the plains of the island. Similarly, in spite to their common characteristics within the context of vernacularism, yet the relative differentiations amongst the settlements may occur in connection with their distance to the major economical and material resources and/or its allocation in their relevant hinterland. This would define the economical structure and the richness of the social life hence the wealth, which was reflected on their **local/regional expression of architecture**. Consequently, the two villages Peristerone-piyi (Alaniçi) and Aghirda (Ağırdağ) were selected within the frame of the thoughts set above (criteria) to be researched and studied **to form a section from the vernacular architecture of Cyprus**.
